

FIRST AMENDMENT TO THE STANDARD FORM OF AGREEMENT BETWEEN

AND

KAUFMAN LYNN CONSTRUCTION, INC. f/k/a  
KAUFMAN LYNN, INC., GENERAL CONTRACTORS

PROJECT NAME: GENERAL CONTRACTOR SERVICES FOR DISASTER RECOVERY ASSISTANCE

This First Amendment made this 18th day of April 2013, to the Agreement regarding General Contractor Services for Disaster Recovery Assistance, entered into on June 3, 2010 by and between THE SCHOOL BOARD OF PALM BEACH COUNTY, FLORIDA (the "School Board") and Kaufman Lynn, Inc., General Contractors, located at 622 Banyan Trail, Suite 300, Boca Raton, FL 33431, to provide General Contractor Services for Disaster Recovery Assistance.

Whereas, the School Board wishes to exercise its first of two options to renew the Agreement dated June 3, 2010. Now, therefore, the parties hereby agree that:

- 1. Effective January 1, 2011, Kaufman Lynn, Inc., General Contractors changed its name to Kaufman Lynn Construction, Inc. Therefore, the General Contractor Services for Disaster Recovery Assistance Owner Contractor Agreement dated June 3, 2010 (Agreement) is hereby amended by interlineation to amend the name of Kaufman Lynn, Inc, General Contractors to Kaufman Lynn Construction, Inc.
- 2. Kaufman Lynn Construction, Inc. shall be responsible and liable for all the liabilities and obligations of Kaufman Lynn, Inc., General Contractors for the full and entire term of the June 3, 2010 Agreement and any successive amendments thereto.
- 3. The June 3, 2010, Agreement regarding the General Contractor Services for Disaster Recovery Assistance is hereby renewed for the first of two options to renew starting June 3, 2013 through June 2, 2014.
- 4. All other terms and conditions of the Agreement shall remain in full force and effect.
