

**ADDENDUM TO THE ARTICULATION AGREEMENT
BETWEEN
THE SCHOOL BOARD OF PALM BEACH COUNTY, FLORIDA
AND
NURSING ASSISTANT TRAINING SCHOOL, INC. D/B/A
ACADEMY FOR NURSING AND HEALTH OCCUPATIONS**

In addition to the terms and conditions as set forth in the Articulation Agreement (the "Agreement") between the School Board of Palm Beach County, Florida ("School Board") and the Nursing Assistant Training School, Inc. d/b/a Academy for Nursing and Health Occupations ("Academy") for School Years 2013 to 2017, the following Addendum is hereby made a part of the original Agreement. To the extent a conflict exists between the Agreement and this Addendum, this Addendum shall govern.

In consideration of the promises herein and other good and value consideration, the parties agree as follows:

1. The Parties agree that their legal names and principal places of business are as follows:

The Academy agrees that it shall not discriminate against any student completing courses contained within the School District of Palm Beach County, Florida's secondary Health Science career pathway curriculum on the basis of his or her race, age, religion, ancestry, color, ethnicity, gender, national origin, marital status, familial status, disability, sexual orientation, gender identity or expression with regard to acceptance for admission and the award of credit hours at the Academy.
3. The parties agree that they may share confidential student information contained in education records only to the extent legally permitted by section 1002.22, Florida Statutes; State Board of Education Rule 6A-1.0955; 20 U.S.C. 1232g ("FERPA"), and 34 C.F.R. Part 99.
4. Except as otherwise modified herein, all of the terms and conditions of the Agreement are hereby ratified and remain in effect without revision.
