1. The Applicant/Bidder, Sprint Spectrum L.P., a Delaware limited partnership, 6200 Sprint Parkway, Overland Park, Kansas 66251, is 99% owned by Sprint Spectrum Holding Company, L.P., a Delaware limited partnership.
2. Sprint Spectrum Holding Company, L.P. is owned by:
  - a. 40% by Sprint Enterprises, L.P.
  - b. 30% by SWV Six, Inc.
  - c. 15% by SWV One Telephony Partnership
  - d. 15% by SWV Two Telephony Partnership
3. Sprint Enterprises, L.P. (as listed in 2a above) is owned by:
  - a. US Telecom, Inc. - 51.01%
  - b. UCOM, Inc. - 48.99%

Each of these entities is in turn owned by Sprint Nextel Corporation.

4. SWV Six, Inc. (as listed in 2b above) is owned by Sprint Nextel Corporation.
5. SWV One Telephony Partnership (as listed in 2c above) is 99% owned by SWV Two, Inc.
6. SWV Two Telephony Partnership (as listed in 2d above) is 99% owned by SWV Four, Inc.
7. The 10% or greater owner of SWV Two, Inc. (as listed in 5 above) is Sprint Nextel Corporation.
8. The 10% or greater owner of SWV Four, Inc. (as listed in 6 above) is Sprint Nextel Corporation.


